**6. Planning**

- **20212250 - Two Jays Farm** - Retrospective planning application for change of use of land for the retention of a mobile home as a rural workers temporary dwelling  
Standing Orders were suspended while the applicant provided an overview.  
Standing orders were resumed and the application was discussed and questions asked - there were **NO OBJECTIONS**
- **20220023 - 36 Patricia Avenue** - Use of the land for siting a mobile home for use ancillary to the main dwelling - **NO OBJECTIONS**
- **20220058 - Land South of Frettenham Road** - 4 hedgerow removals totalling 20 metres to allow installation of new potable water mains - **NO OBJECTIONS**
- **20220084 - 9 Rectory Road, Horstead** - side and rear extension - concerns were raised about how close the proposed extension is to the boundary and the impact this may have on neighbouring properties. The Parish Council to request that windows in the upper storey overlooking the neighbouring property are frosted glass - **COMMENTS**

**7. Parish Clerk and Chairman/Councillors**

- (1) APM** - it was agreed that this would take place on Wednesday 13 April at 7.30pm in the Tithe Barn. The monthly Parish Council meeting will take place on the same day between 6pm and 7.30pm.

- (2) **20212287 - Randells** - Broadland District Council advised that we could only comment as to whether it was true or not that the property had been accessed in the same way for the last ten years.
- (3) **Commemorative 'COVID-19' Plaque** - no response has been received - the clerk to ask if it can be sited in a specific place within the Tithe Barn
- (4) **NPT&S Spring Conference** on 31 March - **APPROVAL** was given for Clerk to attend
- (5) **Road Safety Conference** - 19 April - Mr Jones will be attending
- (6) **Potential new Councillor** - email received from Parishioner - clerk to invite to next Parish Council meeting
- (7) **Car in hedge on B1150** - Mr Jones to contact PC Lucas to ask for information
- (8) A discussion was held about a potential post office in the village
- (9) **Parking on the Pavement** - Mr Kirby advised that the law may change this year making parking on the path illegal - PC Lucas informed Mr Kirby that this may be difficult to police and on certain roads could cause other issues.
- (10) **20210768 - Grove View, Frettenham Road** - Concern was raised that the actual building doesn't comply with permission granted. The clerk to discuss with BDC

- (1) A copy email from Mr Musson with regards to traffic in Coltishall and Horstead was discussed and Jo Copplestone provided more information.

## 9. Pond & Trees

- Mr Jones has been informed that the drain into the pond would benefit from restoration works, something could be done to slow the flow into the pond and catch sediment etc. The Environment Agency often have grants available to carry of this kind of work. **APPROVAL** was given for Mr Jones to pursue this.

## **18. Date and Time of Next Meeting**

Parish Council meeting: Wednesday 9 March 2022 at 6pm in the main hall of the Tithe Barn.

**Jo Coppleson reported** - North Norfolk District Council (NNDC) finally released the Traffic Survey 'technical note' in late January, and I understand the interested parties who asked for the report via a 'Freedom of Information' request also received copies. The Technical Note (TN) is an addendum to the North Walsham Link Road Feasibility Report and assesses the possible traffic impacts of the growth allocated in North Walsham in the emerging NNDC Local Plan on the B1150 section in Coltishall and includes the analysis of the existing traffic situation, especially on the narrow bridge. The TN suggests that by 2036 traffic will increase by 28% to 30% in AM/PM peak hours between 2019 to 2036 WITHOUT the growth allocated in North Walsham, and with the NNDC Local Plan housing growth allocated in North Walsham, traffic volumes are expected to increase an extra 18% and 13% in the AM/PM peak hours respectively. The report concludes 'more detailed analysis needs to be carried out to mitigate imitations highlighted in this TN to obtain a clearer, more robust understanding of the impacts on Coltishall'. In response to NNDC, our Place Shaping Manager has asked how they (NNDC) have arrived at the conclusion that there will NOT be unacceptable impacts on highway safety, or that the residual cumulative impacts on the road network would not be severe, as stated in Paragraph 111 of the National Planning Policy Framework. Furthermore, whether the Highway Authority have set out their views on the conclusions of the TN in respect of traffic growth in Coltishall and what are their intentions regarding the next steps to obtain more detailed analysis? NNDC's Local Plan is now in the Regulation 19 Public Consultation stage, if you would like to comment on the plan and the proposed housing growth in North Walsham please go to [www.north-norfolk.gov.uk](http://www.north-norfolk.gov.uk).
